

**WAIVER & RELEASE OF LIABILITY CLAIMS
AND ASSUMPTION OF RISK ACKNOWLEDGMENT**

ALL PARTICIPANTS of **Woodsmoke Rendezvous reenactment camping experience** must complete the waiver form before the beginning of any activities or entry upon McDaniel Farms property for the purpose of Woodsmoke Rendezvous “1825 Mountain Man” reenactment activities.

In consideration of **McDaniel Farms**, and its owners, agents and assigns, and the **Woodsmoke Brigade**, and its officers, agents, volunteers and assigns, furnishing services and/or equipment, and access to property located in Enterprise, Alabama, to enable me to participate in Woodsmoke Rendezvous- related activities, I agree as follows:

I hereby acknowledge that participating in Woodsmoke Rendezvous presents a risk of personal injury, death and damage or loss of personal property which may result from, but is not limited to the following: participated in shooting sports, namely black powder rifle shooting; tomahawk throwing, knife throwing; archery; land navigation; fire starting and camp/cooking fires; use of tools including but limited to knives, hammers, hatchets, wood saws, and ladders, among others, to construct canvas and wood pole structures; natural hazards including, but not limited to, lightning storms and other adverse weather conditions; domestic or wild animals; fire; travel either on foot or in a vehicle in unfamiliar terrain, artificial and natural obstructions and unimproved roads; the consumption of provisioned or other food and beverages as well as traveling in personal vehicles.

I hereby acknowledge and recognize the existence of these risks, and ASSUME ALL RISKS COMPLETELY, and agree that I SHALL HOLD HARMLESS AND TAKE NO ACTIONS OR SUITS, FOR DEBTS, DUES, SUMS OF MONEY, CLAIMS OR DEMANDS WHATSOEVER AT LAW OR IN EQUITY AGAINST THE McDANIEL FARMS AND/OR WOODSMOKE BRIGADE, their heirs, executors or assigns, for injury, death, property damage or loss associated with relating to or arising from those risks enumerated above or otherwise that occur while I am participating in any stage of a Woodsmoke Rendezvous camping event and when using McDaniel property and/or facilities.

I understand and acknowledge that by signing this document that I have given up certain legal rights and/or possible claims which I might otherwise assert or maintain against the McDaniel Farms and/or its owners, staff, agents or employees, and/or the Woodsmoke Brigade, and its staff, agents, officers or volunteers. These rights are specifically, but not limited to, rights arising from claims or demands for acts of omissions or negligence in any degree (except for gross negligence or willful misconduct) of McDaniel Farms and/or its owners, staff, agents or employees, and/or the Woodsmoke Brigade, and/or its staff, agents, officers or volunteers, and all other related persons or entities. Under no circumstances will McDaniel Farms and/or the Woodsmoke Brigade, its owners, staff, agents, officers, volunteers, or employees be held liable for damages.

I understand that this contract reflects our entire agreement and that my signature indicates that I have read and understand this document and that I have signed this document of my own free will.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE McDANIEL FARMS, THE WOODSMOKE BRIGADE, AND THE PARTICIPANT, AND SIGN IT OF MY OWN FREE WILL. I understand that this waiver applies to any and all Woodsmoke Rendezvous-related activities that I participate in while on McDaniel Farms property, and coordinated or operated by Woodsmoke Brigade members.
